## 4<sup>st</sup> European Championship in Dance Sport

Dear Presidents,

**The IDF 4<sup>st</sup> European Championship in Modern Dance Sport** is coming up soon. It will be held from November 4<sup>th</sup> to November 6<sup>st</sup> 2016 in Brno (Czech Republic) (opening Ceremony and competitions as attached program).

## Technical Card

Every dancer participating in the European Championship is required to have a valid Technical Card. Payment for the Technical Cards should be made via bank transfer directly to the IDF bank account **no later than on October 1<sup>st</sup> 2016**. I'd like to remind as decision of IDF General Meeting, IDF sporting year will be ended on August 31<sup>th</sup> so, European Championship will be the first competition of new sporting year. All dancers who would like to participate in European Championship must pay Technical Cards for 2016 - 2017 sporting year. Of course, who will pay Technical Card to participate in European Championship, will not pay Technical cards on next World Championship who will be held on May 2017.

## Dancers' Registration

As you know, this year registration program will be changed. In order for dancers can to be registered each member country is required to submit their Clubs' names (JUST NEW CLUBS WHO AREN'T INTO THE DATABASE) to [leandro.senesi@idfdance.com](mailto:leandro.senesi@idfdance.com) **no later than on September 10<sup>th</sup> 2016**. The Registrations will be possible till **September 15<sup>th</sup> 2016**. Before September 10<sup>th</sup> 2016 you'll receive link to register Dancers. Username and password to enter into the registration program, will be the same of last World Championship. Registrations made after deadline (October 15<sup>th</sup> 2016) will not be accepted because automatically, program of registration will close. As last World Championship, registrations must be made as Nation and not as individual club. In start program, we will find ONLY THE NAME OF DANCERS' (OR CLUB) NATIONALITY AND NOT THE NAME OF CLUBS. € **50,00** for Small Group;

€ **80,00** for Formation.

**Within October 20<sup>th</sup> 2016 the IDF Secretary Office will send to each President a copy of dancers' register for the final verification as well as the confirmation of the total amount of the participation fees to be paid.**
